## Documents required:

(a) For Basic B.Sc. Nursing Course: Original Migration Certificate of Jharkhand Academic Council/other recognized Boards or Previous R.U. registration Proof (if applicable) and Xerox copy of Mark Sheet and Admit Card.

(b) For Post Basic B.Sc. Nursing Course: Original Migration Certificate of Jharkhand Nurses Registration Council/other recognized Boards or Previous R.U. registration Proof (if applicable) and Xerox copy of the Mark Sheet & Admit Card.

(c) For M.Sc. Nursing Course: Original Migration Certificate of Recognized Boards or Previous R.U. registration Proof (if applicable) and Xerox copy of the Mark Sheet & Admit Card (Basic B.Sc. Nursing) along with one year experience certificate as per INC Norms.

(d) Registration statement must contain the name of the students in the hard copy as well as in the soft copy (Pen Drive).

(e) Approval letter of INC/INRC and affiliation letter of Ranchi University, Ranchi containing the name of the courses and session for which registration form has to be submitted for the above said courses along with sanctioned seats.
